The Chairman welcomed everyone to the meeting and wished everyone season's greetings, Merry Christmas and a prosperous and happy new year. He then requested that each Director declare a conflict of interest at the appropriate time, on any item within this agenda in that a Director may have pecuniary interest.

#### CARRIED

The Chair presented an outline how the hearing would proceed, as per Section 28 (3) Conservation Authorities Act Hearing Guidelines, October 2005, prepared by Conservation Ontario and Ministry of Natural Resources and an explanation of the *Conservation Authorities Act*. Roll Call was taken.

Dallas Cundick then presented an outline of the Core's application and explained the Authority's staff recommendations as they pertain to the St. Clair Region Conservation Authority's policies and the hazard that exists at the site.

#### **Background**

SCRCA Lake Huron Shoreline Policy for Major Additions at the Subject Location States;

1. Major Additions;

a. total proposed area for the addition is greater than 30% and less than 50% of the existing foundation area or footprint area (whichever is the lesser amount); Summary of Pre-Consultation Steps/Chronology of Discussions with Landowners

Step 1:

• existing dwelling footprint is 69 sq. m, and therefore a 34.5 sq. m addition is permissible onto the landward side of existing dwelling;

Step 2:

• CA staff discussed with landowner that the existing detached garage could be removed, and its footprint (41 sq. m) could be used as permissible addition sq. area for addition onto existing dwelling;

Step 3:

- CA staff discussed with landowner that potentially the existing dwelling could be relocated outside the 60 yr. RR, the existing detached garage could be removed, and the combined footprint of the existing dwelling and existing detached garage could be used to determine the total square area permissible for relocated/redeveloped dwelling with addition and attached garage;
  - therefore, total square area for proposed relocated/redeveloped dwelling with addition and attached garage to be no greater than 164 sq. m;
    - due to the buildings existing on-site, staff of the SCRCA thought this approach reasonable and within policy framework;

Therefore, as per SCRCA policies and pre-consultation with landowners, permitted total square area allowed (relocated structure plus additions) no greater than 164 sq. m.

o 164 sq. m meets Plympton-Wyoming Zoning By-law;

Core's submitted application with proposed relocated dwelling and additions with total gross square area of 251.5 sq. m.

- Core's application was for total gross square area of 251.5 sq. m, this is an
- approximately 130% total gross square area addition to existing combined footprint. • therefore:
  - the proposed relocation and addition does not meet SCRCA Lake Huron Shoreline policies. Proposed development extends beyond relocation and major addition and constitutes redevelopment or new structural development.

SCRCA Shoreline Policies dictate that:

- o for new structural development within the Erosion Hazard;
  - the development must be setback a minimum distance equivalent to the Stable Slope Hazard plus 60% of the Erosion Hazard while considering the protection works standard and access standard to the maximum extent and level possible ;
- as outlined through technical studies single lot protection is not feasible at this reach of shoreline;
- o therefore, recommended that this application for permission be denied.

Directors Comments & Concerns:

- two parts to the decision 1) redevelopment 2) size of development.
- if plans were within the 164 sq. m requirements, would the application have been approved?
- would more square footage be allowed if variance obtained from municipalities?
- is the 60 year limit acceptable to Authority staff?
- if the development is set back as far as possible, how does that affect the toe of bank?

- (the plans show moving the house as far back from the top of bank as possible, but that's only to the 60 year line, not the 100)
- what about the other houses on Bluepoint?
- is there information on any modelling done recently to get clearer picture? (*in 2010 the Authority hired Baird to update the recession rates. No change in recession rates for minimal increase from 1996 Shoreline Plan.*)
- lake levels are low now, still significant concern for erosion in that area.
- why does the Conservation Authority allow a 60 year limit when 100 is the norm (*short answer: for existing residential lots SCRCA policy to permit conditional on limits to area/footprint addressing erosion (coastal etc.)*
- main building footprint is relocated about 5 m away from top of bank

The property owners Nick and Chantelle Core presented their thoughts on their application:

- their application was based on a collaboration of their family's needs and the rules of the Authority
- purchased the house in 2008 and did understand that there where limitations on how they could expand on their property.
- they are not requesting a grand extravagant home, but would be small enough to live comfortably with their family.
- the obtained a geotechnical study on the property and decided to move some of the buildings so they would be outside the 60 year line.
- they have exceeded the square footage policy, but asked for leniency to meet with that regulation.
- storm sewers are now in place.
- they feel they are making an investment and have no concerns. They have no intention of putting their family at risk.
- they have talked to Lambton County regarding a variance to move closer to the road.

The Core's designer, Travis Bouma talked with engineers and geotech engineers and neither had concerns with the design.

Directors comments and concerns:

- explain square footage issues, first calculations only include main floor, our calculations include all floors
- would taking away bedroom above garage make a difference?
- (must minimize risk to life and property).
- what is the percentage of increase of footprint from original? (D.Cundick response = 100% increase in footprint from original dwelling);
  - existing dwelling footprint is 69 sq. m
  - proposed relocated/redeveloped dwelling etc. footprint is 138 sq. m.
  - proposed relocated/redeveloped dwelling footprint is 100% increase in footprint of existing dwelling footprint.

why did the property owners go above the municipal zoning bylaw? 50% if not a minor variance.

- Lambton County planners are in support of the plan. (*This was what the Cores said verbally to the board during their presentation. Staff of SCRCA have no verbal or written confirmation that County has no objections to proposed plan.*)
- Conservation Authorities would like plans downsized.

#### CARRIED

A Conservation Lands Update was reviewed:

- Conservation Lands Maintenance and Development:
  - C.J. McEwen Conservation Area (Plympton-Wyoming):
    - a new steel roof has be installed on the washroom building
    - a number of dead poplar trees have been removed
  - Peers Wetland Conservation Area (Chatham Kent):
    - a gravel parking lot has been completed
    - gravel has been placed inside the pump control structure
    - renewal leases have been prepared for both tenants (Cogeco and Wallaceburg Outdoor Club)
  - Bridgeview Conservation Area (Petrolia):
    - railings on the dam have been removed (to eliminate ice damage to the railings during spring floods) and they will be reinstalled by mid-April
  - Strathroy Conservation Area (Strathroy):
    - a number of dead ash trees have been removed from along the trail system
    - staff have completed the street tree planting inventory for the municipality; this involving mapping future tree planting locations using GPS technology; this information will assist the municipality to plan, budget and implement a tree planting program
  - Warwick Conservation Area (Warwick):
    - rip rap erosion protection has been installed under the main trail bridge
    - staff are working with the municipality and the adjacent landowner to secure an alternate access roadway into the conservation area (present access roadway is being eroded by an adjacent stream)
    - a number of dead ash trees have been removed
  - A.W. Campbell Conservation Area (Brooke-Alvinston):
    - structural repairs have been made to the sugar shack and the Campbell House museum pavilion
    - a number of dead ash trees have been removed
    - staff have performed property inspections and installed "no hunting" signs at the following properties; Harrison Woodlot, Sinclair, Gawne, McAlpine Forest Tract, and McPhail Forest Tract.
- Tree Planting:
  - 70 hardwood and 60 wildlife shrubs have been planted in our conservation areas, McKeough and Lambton County lands.
- McKeough Lands:
  - soil erosion works have been completed on property 82; this involved a series of berms and hikenbottoms which were installed along the eroded slope of the agricultural field
  - 3 surplus farm buildings have been demolished

BD-13-088 Bruinink - Boushy "That the Board of Directors acknowledges the Conservation Lands Update, dated November 22, 2013 concerning maintenance and development on conservation areas, and McKeough Upstream Lands."

#### CARRIED

A staff report on water levels, current and flood conditions was presented. Watershed Precipitation and Streamflow Conditions:

- highlights:
  - increased flow events due to precipitation in November
  - falling temperatures result in snow accumulations
  - lake levels returning to close to the 10 year average
  - recent urban flood overview (Calgary and Toronto)
- precipitation events through September and October in some cases in excess of 100mm (4 inches) accumulating over short periods, have resulted in significant rainfalls in the upper reaches of the Sydenham River notably in the Strathroy area and beyond into the London area watersheds. In contrast, several significant rainfall events in November had a significant impact on water levels in many areas. Ground conditions were already saturated from significant precipitation throughout the previous months and flows were subsequently affected. Flows returned to normal seasonal levels quickly and as temperatures decreased to below zero in the latter part of the month much of the new precipitation has resulted in snowfall accumulations. Moving into December, there will remain the chance of periods thaw which may release accumulated snow pack into the watercourses resulting in higher flow conditions moving to the end of 2013. The annual snow survey program was initiated mid-November to record accumulations and the equivalent water content thus providing greater accuracy when determining the potential for high flow conditions in the event of a sudden thaw. Precipitation totals for November were not complete at the time of this report but complete end of year statistics will be included in the next report.
- Weather Forecast (Weather Network, Environment Canada)
  - December slightly below average temperatures with above average precipitation in the form of snow mid-month (70% chance of white Christmas)
  - Fall and Winter Temperatures will be near normal with slightly above normal precipitation into the winter months
- Great Lakes Levels
  - Lake Huron levels continue to improve over last year extremely low levels increasing by 27cm (10.6 inches) but remain slightly below the 10 year average -5cm (2inches). As each station receives flow from the previous water body the relative impact on levels are identified downstream from Lake Huron to Lake Erie.

#### CARRIED

A staff report summarizing Fish Habitat Review activities was presented.

• the federal government announced their intention to amend the Fisheries Act in 2012, and these

amendments came into full force on November 25, 2013. Due to these changes the existing partnership agreement between DFO and the SCRCA regarding fish habitat review is cancelled as of that date. The SCRCA is suspending fish habitat review activities until we hear further details from DFO on their new "Fisheries Protection Program" and the future of the partnership expected in April 2014.

- upon municipal request, staff are willing to review projects for their fish habitat implications on a case by case basis.
- when we have sufficient details on a new Memorandum of Understanding between DFO and the SCRCA, we will return to the Board for further direction.
- recommendation: that staff inform our municipalities of the change in fish habitat review activities as outlined above.
- previous activities: Prior to November 25, as part of our Level 2 Service Agreement with Fisheries and Ocean Canada (DFO), SCRCA was conducting an initial review of drain projects to identify any impacts to fish and fish habitat. SCRCA would determine how the proponent could mitigate any potential impacts to fish and fish habitat. If impacts to fish and fish habitat could be mitigated, then the Conservation Authority issued a letter of advice. If impacts to fish and fish habitat could not be fully mitigated, the project was forwarded to the local Department of Fisheries and Oceans for further review.
- the partnership with DFO helped municipalities avoid delays in obtaining advice or authorization approvals from DFO
  - review helped municipalities avoid damage to fish habitat and potential fines or prosecution under the Fisheries Act
  - improved sediment control, erosion control and off-season timing improves the water quality and aquatic habitats in the SCRCA and keeps the soil on the land
- files Processed for Level 2 Service Agreement
  - between January 1 2013 and November 25 2013, 204 drain files were reviewed under the Agreement by St. Clair Conservation staff.
- from June  $1^{st}$  to November 25, 2013, 95 files were processed under the Agreement with DFO.

A staff report regarding cost recovery for implementation of the provincially mandated DART process we considered.

• with the approval of the provincial "Generic Regulation" in 2006 for all Conservation Authorities (CAs), all CA Regulations were updated to ensure conformity of wording and complement municipal implementation of provincial policies under the Planning Act such as hazardous lands and wetlands. The clarification and wording update in the "Generic Regulation" meant open

municipal drains met the definition of a watercourse as defined in the Conservation Authorities Act and therefore fall under the regulatory authority of conservation authorities. Since 2006/2007, the CA's along with other provincial organizations formed DART, a Drainage Act and Regulation Team, to streamline approval processes for drain maintenance and repair. In April 2013 the Board authorized staff to use the provincially accepted and approved DART protocol with the direction for staff to monitor staff requirements to implement the protocol and provide recommendations on appropriate cost recovery options.

- *DART Cost Recovery* Board Report presented at the September 19, 2013 meeting proposed a minor and major works DART review fee of \$200 and \$600 respectively. The question was posed in response to the report: can fees be added to the drainage report? At the time of discussion, staff responded that fees can be added to the drainage report.
- after the meeting further clarification on the matter was sought by staff. It was found that other conservation authorities (e.g., Upper Thames), invoice municipalities for the review fee. In turn municipalities add the associated costs to the final drainage work bill for the landowners. OMAFRA has agreed to pay grant on the amount levied to the agricultural property owners.

An amendment to the proposed motion was considered.



# **Outline of Erosion Control Structure Maintenance for 2014**

The following structures were constructed with Authority project management and grant from the Ministry of Natural Resources and as a result these projects are eligible for potential funding to support the maintenance of these projects. The potential grants are for inspection and maintenance of the structures at a grant rate of 50%.



### Sarnia Erosion Control Project

The Sarnia Erosion Control Project protects Old Lakeshore Road, the adjacent properties and their access and major utilities in Brights Grove. Constructed between 1989 and 2001, the project remains in good condition. Continued monitoring of the conditions of the work will avoid major maintenance costs in the future. Planned works for 2014 include: continued control and removal of woody vegetation, placement of rip rap to improve pedestrian access and reduce safety concerns and improvements to viewing platforms and access stairs. A sheet pile groyne located east of Pine Avenue was replaced in 2013

# Cathcart Park Shoreline Rehabilitation Project

The first and second phase of work has been completed on the shoreline protection at Cathcart Park in St. Clair Township. The study/design phase of this project was started in 2009 to protect and improve approximately 1,000 meters of shoreline. The work is geared to replace a failing steel sheet pile wall with a revetment comprised of stepped armour stone and sloped rip rap. The second phase of construction was completed in February 2013 and provided protection to about 100 meters of Shoreline. The Third Phase of work is planned for 2014 to provide shoreline rehabilitation to another 100 meters of St. Clair River shoreline.





### **Point Edward Erosion Control Project**

The Point Edward Erosion Control Project is located on the St. Clair River in the Point Edward Waterfront Park and was constructed in 1995. The project is in good condition but is impacted annually by vandalism and loss of material due to stone shifting from wave and ice action. The timber curb that defines the boundary between the structure and the adjacent grass areas along the walkway is beginning to break down and will require gradual replacement over the next several years. Annual inspections and minor maintenance will ensure the longevity of the protection.

Works planned for 2013 will include: timber curb replacement, placement of additional clear stone in the voids on the top of the structure and the control of woody vegetation.



### Wallaceburg Retaining Walls

Many of the retaining walls in the community of Wallaceburg were constructed with SCRCA project management and provincial grant. Most of the projects are in fair condition but will be requiring maintenance of one form or another over the next several years. Annual inspections and minor maintenance will ensure the protection of the properties. Removal of oversized woody vegetation and placement of various sizes of rip rap at several locations to control minor erosion issues are anticipated works for 2014.

### **Minor Maintenance of Authority Structures**

An Engineering study carried out in 2012 pointed out the need for minor maintenance of several authority structures. Most structures are in good condition; however some cracks have appeared and should be repaired. SCRCA will establish a repair program in 2014 and minor cracks will be fixed at the following structures:

- 1) Petrolia Dam
- 2) Head Street Dam
- 3) Coldstream Dam



# Watershed Precipitation and Streamflow Conditions

Winter conditions have been experienced across the watershed since early December with mean temperatures in December of minus 3.7 degrees and then significantly colder in January with minus 9.7 degrees. With lower temperatures snow accumulations were experienced all many areas resulting from snow storm events in early December only to be lost with slightly warmer temperatures and subsequent rainfall mid-month. Flows were increased at this time with combined snow melt and additional precipitation falling as rain during this period. This pattern was repeated following extreme cold temperatures in the first week of January when large amounts of snowfall coupled with 20 to 30mm of rain increased levels for an extended period over the first week (fig 1) followed by a milder period. During this time ice became soft and in many places dislodged into flowing ice sheets which then quickly refroze as temperatures fell overnight. In most locations, while the quality of the ice was impacted, there appears to have been limited movement of the ice pack in most watercourses however any flooded areas have now frozen in place.



**Regional precipitation numbers** (fig 2) indicate near normal precipitation in guarterly and the last six month periods but rainfall from the early part of the year helped to improve overall numbers by 20% for the entire year. Interestingly errors in Environment Canada climate data reporting for Sarnia resulted in a report of 360mm of precipitation



Conditions continue to be variable across the watershed but significant amounts were lost in the second week of January. Conditions are monitored on a bi-weekly basis together with the integrity of river ice at strategic locations. Currently watercourses have 6 - 8 inches of white slightly deteriorated ice with some open sections near higher flow areas. All areas are anticipated to thicken into February with the extremely cold temperatures together with increased snow cover. Some ice jams have been experienced in the St. Clair River but ice remains in place in the Chenal Ecarte and into the mouth of the Sydenham River.

Communication protocol was handed out and will be included in the SCRCA ice management documentation for 2014. Discussion included review of response time for equipment arrival and times at Wallaceburg.

- staff reviewed and revised the old hunter permission agreement. With input and assistance from OMNR Conservation Officers, the agreement has been updated
- the new version of the permit was received positively by most hunters and more review and revision is required for the 2014-2015 permit, which is currently being completed.
- adding membership in the Ontario Federation of Anglers and Hunters as a prerequisite to obtain permission to hunt the upstream lands, as OFAH carries \$3 million liability insurance on its members, was viewed as a positive by most hunters with a handful complaining about the added cost.
- the controlled deer hunt zone draws were not required this year as the number of hunters applying for each zone were within our allowable numbers, which allowed every hunter to hunt their first zone choice.
- the hunting list was emailed to enforcement agencies once the list was finalized and complete.
- CA Staff installed property marker signs at the property boundaries along roadways to assist hunters, enforcement staff as well as CA staff with property locations.
- this is the first year that CA staff have not had a complaint from other hunters or neighbors or found a violation regarding hunting issues on CA Lands.
- CA Staff are currently reviewing and revising our hunting permit package to make it more user friendly as well as implementing some of the suggestions from hunters and CA staff.

### **Purpose of Hearing:**

Application has been received by the Authority requesting permission under Section 28 of the *Conservation Authorities Act* to relocate/redevelop on the subject property on the Lake Huron Shoreline. A hearing is being held as staff and the SCRCA Regulations Committee have recommended denial of the application (Exhibit A -Regulations Committee Report) and requests a hearing before the Board of Directors.

### **Background:**

The subject property is located on the Lake Huron Shoreline in the Bluepoint Area. The lot is situated on the north side of Bluepoint Drive and measures approximately 65 metres deep with approximately 18 metres of frontage on Bluepoint Drive. The top of the bank is irregular however; it is approximately 49 metres on average, from the front property line. See attached maps and photos.

### **Technical Background:**

The SCRCA Shoreline Management Plan (Baird 2010) indicated that erosion rates along this reach of shoreline are approximately 0.41 metres per year and that the bluff height at this location is approximately 16 metres.

• Note, The SCRCA Shoreline Management Plan (1996) (SMP) indicated that erosion rates along this reach of shoreline are approximately 0.395 metres per year and that the bluff height at this location is approximately 16 metres.

The SMP further notes that undercutting at the toe of the bluff by wave action causes instability and success shallow slips on the bluff face but also deeper internal rotational slumps. Wave uprush during storm events is intensified during periods of high lake levels and instability is aggravated by landside influences such as drainage, loading & groundwater seepage – Exhibit B

A Bluepoint Bluff Erosion Protection Benefit/Cost Analysis (2003) found that providing erosion protection is not feasible along this reach of shoreline – Exhibit C is the summary from this report.

At the request of the landowners along the Bluepoint reach of shoreline and with Municipal support, the Authority undertook the "Blue Point Recession Study (2004) to evaluate and determine whether the recession rate for the Bluepoint reach of shoreline should be revised. The study found that the erosion hazard limit and stable slope allowance have not changed substantially and does not warrant re-mapping. Exhibit D is the Executive Summary and Discussion/Conclusions excerpt from this report.

The proponent undertook a Geotechnical Engineering Report completed by LVM, dated November 2, 2012, titled Slope Stability Assessment, 4090 Blue Point Drive, Plympton-Wyoming, Ontario (Ref. No.: P161-B-0003264-1-GE-R-0001-00). Report indicates that the stable slope with appropriate factors of safety for residential development is 23 degrees; therefore stable slope allowance is 37.7 metres. Exhibit E.

The proponent also undertook a Shoreline Hazards Assessment completed by Shoreplan Engineering Limited, Titled 4090 Bluepoint Drive, Plympton-Wyoming, Our File 12-1871, and dated March 11, 2013. The Shoreplan coastal report states that the subject property is currently unprotected from erosion and erosion protection is not feasible on a lot by lot basis on a bluff of this height. Shoreplan states "We also gave consideration to the potential of erosion reduction by using shore protection. Given the height of the bluff, the use of shore protection on a single residential property is generally not recommended". Shoreplan also states a collaborative (erosion) project with your neighbours may be economically feasible in future to reduce erosion given the nature of the nearshore and substantial quantity of large boulders in the vicinity and directly to the west of the subject property. (Shoreplan, 4090 Bluepoint Dr, 03/11/13, p. 4). Exhibit F.

### **Proposal:**

The applicant has proposed a relocation/redevelopment included moving the existing dwelling outside the 60 yr. erosion hazard, constructing a new foundation with full basement, and constructing an addition to the existing dwelling, and a new 2 car attached garage with basement;

This proposal would put the lakeward side of the dwelling approximately 24.6 metres from the engineered stable slope allowance (37.7 m) at its closest location which is roughly equivalent to 60 year erosion allowance, based on the engineered erosion rate of 0.41 metres per year. The proposal would result in a relocated/redevelopment dwelling that will have total gross square area of approximately 218 sq. m, and the dwelling will be located 1.78 m from the west property line and 1.40 m from the east property line.

The proposal does not meet board approved SCRCA Shoreline Development Policies for permitted relocated structure plus addition (Policy is provided later in this report);

- Permitted total square area (relocated structure plus addition) no greater than 164 m 2;
  - Staff utilized the following to determine allowable permitted total square area of 164 m<sup>2</sup> as noted above (not including basement);
    - Existing dwelling footprint (69 sq. m);
    - Existing detached garage to be removed which is located between existing house and top of bank (41 sq. m);
    - Total footprint is 110 sq. m.;
    - As per policy major additions allowed up to 50% of existing footprint;
    - Relocation/redevelopment should be completed outside the 60 yr. erosion hazard;
      - Relocation is recommended and should be complete outside the Erosion Hazard (MNR Tech Guide);
      - Outside the 60 yr. is greatest extent possible on property;
    - 110 sq. m divided by 2 = 55 sq. m;
    - Therefore, total square area allowed is approximately 165 sq. m;
    - Plympton Wyoming Zoning By-Law Allows 164 sq. m maximum gross floor area building area;
    - Therefore 164 sq. m meets SCRCA policy and Zoning By-Law;

### Legislation:

Prior to May 2006, the Authority's involvement with shoreline development was primarily as an advisory agency to our member municipalities and the general public, providing comments with respect to Natural Hazards as per Section 3.1 of the Provincial Policy Statement.

In 2006, the *Conservation Authorities Act* (Exhibit G) was amended as part of the Red Tape Reduction Initiative and regulations implemented pursuant to Section 28 of the *Act*. These regulations are entitled "Development, Interference with Wetlands and Alterations to Shorelines and Watercourses" (O.R. 171/06 – Exhibit F). With the approval of O.R. 171/06, Conservation Authorities are responsible for issuing development approvals in regulated areas, including shoreline areas that were not previously regulated under the old "Fill, Construction and Alterations to Waterways" Regulations.

Conservation Authorities Act (relevant sections):

#### "Regulations by authority re area under its jurisdiction

**28.** (1) Subject to the approval of the Minister, an authority may make regulations applicable in the area under its jurisdiction,

(c) prohibiting, regulating or requiring the permission of the authority for development if, in the opinion of the authority, the control of flooding, erosion, dynamic beaches or pollution or the conservation of land may be affected by the development;

#### **Right to hearing**

(12) Permission required under a regulation made under clause (1) (b) or (c) shall not be refused or granted subject to conditions unless the person requesting the permission has been given the opportunity to require a hearing before the authority or, if the authority so directs, before the authority's executive committee. 1998, c. 18, Sched. I, s. 12.

#### Powers of authority

(13) After holding a hearing under subsection (12), the authority or executive committee, as the case may be, shall,

(a) refuse the permission; or

(b) grant the permission, with or without conditions. 1998, c. 18, Sched. I, s. 12."

O.R. 171/06 – Development, Interference with Wetlands and Alterations to Shoreline and Watercourses (relevant sections):

#### "Development prohibited

**2.** (1) Subject to section 3, no person shall undertake development, or permit another person to undertake development in or on the areas within the jurisdiction of the Authority that are,

(a) adjacent or close to the shoreline of the Great Lakes-St. Lawrence River System or to inland lakes that may be affected by flooding, erosion or dynamic beaches, including the area from the furthest offshore extent of the Authority's boundary to the furthest landward extent of the aggregate of the distance in subclause (i) or (ii), as applicable, and the distances referred to in the subclauses (iii), (iv) and (v),

(iii) the predicted long term stable slope projected from the existing stable toe of the slope or from the predicted location of the toe of the slope as that location may have shifted as a result of shoreline erosion over a 100-year period,

#### Permission to develop

**3.** (1) The Authority may grant permission for development in or on the areas described in subsection 2 (1) if, in its opinion, the control of flooding, erosion, dynamic beaches, pollution or the conservation of land will not be affected by the development. O. Reg. 171/06, s. 3 (1)."

Consistent with the Provincial Policy Statement, O.R. 171/06 directs the Authority to consider development and potential impacts associated with a natural hazard over a 100 year time frame.

To summarize the above, the Authority may grant permission for a development to occur within an identified natural hazards concern area, if in the opinion of the Authority, the control of flooding, erosion, dynamic beaches or pollution or the conservation of land will not be impacted by the development. Exhibit H is O.R. 171/06.

### **SCRCA Shoreline Development Policies:**

SCRCA Lake Huron Shoreline Policy (Exhibit I) indicates that relocation should be considered as a future option, and that major additions may be permitted on existing identified lots of record provided the following conditions are met:

The construction of accessory structures and additions to residential dwellings may be permitted within the Erosion Hazard, provided the following criteria have been addressed to the satisfaction of SCRCA:

- 1. The proposed addition does not intensify the use of the existing structure;
- 2. The proposed addition does not increase the occupancy of the existing structure;
- 3. The proposed addition/accessory structure does not aggravate the existing hazard;
- 4. The proposed addition/accessory structure does not diminish maintenance access to any existing protection works;
- 6. Major Additions;

a. Total proposed area for the addition is greater than 30% and less than 50% of the existing foundation area or footprint area (whichever is the lesser amount); b. Meets a minimum setback the greater of:

15 metres from the Stable Slope Hazard (Note: for bluff shoreline with low erosion rates, the minimum setback from the Stable Slope Hazard can be reduced to 6 metres at the discretion of SCRCA staff)

OR

50 year Erosion Hazard from the Stable Slope Hazard;

c. The development is located at the most landward extent possible and utilizes the maximum lot width possible;

### Items to Consider:

Staff of the Authority completed two property inquiries in 2012 (March 7 and June 13) in regard to Authority requirements for an addition at the subject location. Staff of the SCRCA met with the proponent on January 11, 2013, Authority staff discussed with all parties (exception: M. Sturm of Shoreplan) a revised proposal which would mean relocation/redevelopment as opposed to an addition onto the existing dwelling at its existing location.

This would allow positioning a residence farther from top of bank. This is a positive step in respect to the Conservation Authority's position. A relocation/redevelopment would also allow an improved foundation/full basement, which the landowner preferred.

Plans were submitted that come close to meeting CA policy and therefore the staff of the SCRCA moved forward in this respect.

The proposed relocation/redevelopment included moving the existing dwelling outside the 60 yr. erosion hazard, constructing a new foundation with full basement, and constructing an addition to the existing dwelling, and a new 2 car attached garage with basement;

In respect to reasonable additional area in a hazard area (i.e. addition onto relocated dwelling), staff of the Authority requested the proponent revise the conceptual floor plan drawing slightly to ensure the following:

- Relocation of the structure outside the 60 year erosion hazard limit based on stable slope determined by LVM;
- Permitted total square area (relocated structure plus addition) no greater than 164 m 2;
- 1.8 m side yard, minimum one side only for access purposes.

Staff of the SCRCA discussed the following with the landowner;

- It is reasonable to state that the new structure will be outside the 60 year recession based on 2010 recession calculations. This will be a better situation than currently exists.
- To recognize the aforementioned and that protection is not recommended on a lot by lot basis, and is not to be carried out at this time, the following is needed and will be a condition of approval: provision of certification to the Authority that the survey of the property, clearly delineating the stable slope hazard and 60 year erosion hazard line has been registered on title of the property. (Recommended contacting Nisbet Roberston in this regard). (FYI We required this of O. Dodd's property/proposal).

Staff of the SCRCA stated that, if the 3 bullet points as noted above are addressed and a survey is registered on title as described; staff of the SCRCA will not have a concern with the approval of the development proposal.

In September 2013, the proponent proceeded with an application for development for a relocated/redevelopment dwelling that had a total gross square area of approximately 251.5 sq. m. A hearing was held on December 12, 2013 and the following was decided;

Miller – Faas

"That the Hearing Board in accordance with the requirements of the Conservation Authorities Act, held a hearing regarding Nick & Chantelle Core, Application #10840 on December 12, 2013 and hereby refuses the application and directs staff to issue a Notice of Decision accompanied by the required information regarding the right to appeal."

### CARRIED

BD-13-082 Gillis – McEwen "That fees for a new application for development on the site within 60 days for this applicant be waived, as works to administer and review the application has been recently reviewed." CARRIED

The proponent has submitted a new application with conceptually the identical proposal in regard to exterior

- structure, foundation footprint, etc., with the below revisions;
  On the second floor plan the master has removed 139.9 sq. ft. (14.5 ft. by 9.5 ft.) of finished floor space from above the garage (the roof line has not been altered etc.);
  - The third floor den floor space has been removed, total of 221.2 sq. ft. (the exterior walls and roofline are still proposed to extend to elevation of 28 ft. 9 11/32 inches (9 m) at this location;

### Photographs and Background on Bluepoint Drive Area

A number of the larger trees on the slope along the Bluepoint have significantly curved trunks – indicates signs of movement and rotational slumping at some time in the past – Exhibit J taken in 2009 just east of subject property.

Exhibit K is a typical rotation slumping diagram taken from the Provincial Technical Guides. It is noted that on several lots to the east in photos taken in 2009, the shoreline bluff contained only sparse or spotty vegetation and included many areas of exposed clay - indicates a relatively recent surficial erosion event or events have occurred – Exhibits L, M, N.

Exhibit O is a photo taken November 4, 2009 approximately 230 metres updrift (east) of the subject property – demonstrates features typical of a rotational slump and identifies new toe erosion at the bottom of the slope as well.

Exhibit P is a photo taken in April 2005 east of the subject property shortly after a surficial erosion event occurred along Bluepoint Drive.

Exhibit Q is a photo taken in 2004 showing top of bank erosion. Photo is taken in close proximity to Bluepoint and the subject property.

Exhibit R, S, T show historic photos of erosion along the shoreline at the subject property during varying water levels and storm conditions. Photos taken 1977, 1973, and 1980.

Exhibit U, V, show aerial photos taken in 2011 depicting varying degrees of vegetated banks and areas with sparse vegetation and exposed clay.

Water levels in Lake Huron have been below average for a number of years (approximately 10 years) and remain below average to date.

#### **Recommendation and Reasons:**

Deny permission to relocate/redevelop as proposed on the subject property, as the application does not adhere to SCRCA Shoreline Development Policy requirements.

Substantial evidence and photos exist that indicates erosion processes continue to occur along this reach of the Lake Huron shoreline, even with lower than average lake levels experienced over the past several years. The high bluff, steep incline and erodiblity of the nearshore have resulted in a significant risk area at this location.

### **IMPORTANT NOTE:**

Proposed Development extends beyond relocation and major addition and constitutes NEW Structural Development;

SCRCA Shoreline Polices dictate that for NEW Structural Development;

- The development must be setback a minimum distance equivalent to the Stable Slope Hazard plus 60% of the erosion hazard while considering the protection works standard and access standard to the maximum extent and level possible;
- As outlined previously through technical studies single lot protection is not feasible at this reach of shoreline;
- THEREFORE, the protection works standards requirements for NEW Structural Development cannot be met;

The Authority is willing to provide flexibility in permitting a relocation/redevelopment proposal outside the 60 year erosion hazard with total square area (relocated structure plus addition) no greater than 164 m 2. It is the position of staff and the Regulations Committee that any reduction beyond this limit and proposed development beyond the total square area of 164 m<sup>2</sup> exposes the Authority and applicant to risk to life and property in a significant hazard area.
