Position Summary

The St. Clair Region Conservation Authority (SCRCA) is looking to add to their team, Lifeguards and Assistant Lifeguards. These positions will require working with other Conservation Area staff to ensure the safety and enjoyment of swimmers at Conservation Area pools and ensure facilities are cleaned and maintained.

Duties and Responsibilities

- Ensure the public is observing safe swimming practices in the pool and on the pool deck.
- Inform the public of water safety practices.
- Perform rescues and administer first aid/CPR, as required.
- Ensure all required safety equipment is in place, prior to pool opening, as per regulations.
- Perform day-to-day pool operations including water testing, general housekeeping/custodial duties, and monitoring of filtration and chemical systems.
- Maintain proper record keeping in accordance with local and provincial COVID-19 guidance and regulations.
- Address customer concerns and complaints.
- Assist the general public by providing information on policies, regulations, facilities, and general information.
- Eject individuals that endanger themselves or other swimmers from the pool area and document/record incident.
- Other duties as assigned by the Conservation Area Superintendent or Assistant Superintendent.

Credentials and Experience

- Valid National Lifeguard Service (NLS) certification and current First Aid and CPR certification (Lifeguard).
- Valid Bronze Cross or Award of Distinction (Assistant Lifeguard).
- Up-to-date or ability to provide Criminal and Vulnerable Sector checks.
- Exceptional customer service, communication, and interpersonal skills.

- Energetic with positive attitude and ability to work independently.
- Willing to work flexible hours including evenings, weekends, and holidays.
