#### **Position Summary**

The St. Clair Region Conservation Authority (SCRCA) is looking to add to their team, two Conservation Area Gatehouse Attendant & Maintenance staff. The Gatehouse Attendant & Maintenance positions are responsible for providing quality customer service to campground visitors and performing routine facility and grounds maintenance.

#### **Duties and Responsibilities**

- Provide quality customer service.
- Take camping reservations, issue campsite permits, collect fees, prepare shift reports, and advise staff of check in and check out information.
- Assist the general public by providing information on policies, regulations, facilities, and general information.
- Open and close facilities as required.
- Assist in controlling and regulating visitor access to the Conservation Area.
- Perform maintenance duties including washroom and grounds cleaning, cutting or trimming grass/vegetation, cleaning fire pits, garbage collection, nature trail maintenance, etc.
- May be required to assist in the organization, promotion, and delivery of social activities and events.
- Carry out all assigned duties in accordance with accepted safety practices.
- Perform other duties as assigned.
