### **Position Summary**

The St. Clair Region Conservation Authority is looking to add a GIS Projects Technician to their team. The GIS Projects Technician will report to the GIS Specialist and will be responsible for fulfilling a range of operational responsibilities that support special GIS projects within the IT/GIS department. Additional GIS data creation and analysis will also be required to fulfill various other departmental GIS task needs.

Hiring for this position is dependent on the securement of external funding.

## **Duties and Responsibilities**

- The primary responsibility will be to complete several special GIS projects within the GIS/IT department.
- Work on the data creation, acquisition, organization, documentation, metadata, and analysis of related project activities.
- Complete any formal reports and package any/all project deliverables for associated projects as required.
- Secondary duties include responsibilities for the purpose of cross training and backup coverage. This may include support for end-user applications. This position will also have a supporting role in networking among agencies and organizations with respect to data collection, data sharing, data maintenance and co-operative projects.
- Responsible to work safely following legislated and employer Safe Work Procedures/ Practices.
- Be a player with extraordinary organization, interpersonal, and oral and written communication skills.
- Follow Health & Safety protocols.
- Other duties as assigned.

# Credentials and Experience

- Graduate from a recognized post-secondary institution with training in GIS/Geomatics, photogrammetry, remote sensing, Geography, or a related discipline.
- One to three years of experience in GIS with a strong understanding of principles and concepts.
- Experience with QGIS and ESRI ArcGIS Desktop products
- Familiarity with GPS, computer system applications, Python and Model-Builder is desirable.
- Ability to work alone or with a partner with little supervision.
- Strong organizational skills.
- Strong ability to communicate effectively both verbally and in writing in English with diverse stakeholder groups at a political and staff level.
- Ability to work well with other staff.
- Initiative and good interpersonal skills.
- Must possess and maintain a valid Ontario "G" driver's license.
